Great Family Organization (GFO), is a national, non-profit Organization, founded in January 2006 at HAC South Darfur State as a local CBOs and Registered as a NNGO in 2018 determined to provide services to those people affected by conflicts and disaster and to advocate for protection of vulnerable population peace and trust building among IDPs, returnees and host communities.

Our Vision

Our Mission

GFO as a non-governmental organization dealing with emergency interventions as well as recovery and development through peace building and reconciliation. Building capacity to produce self- livelihood is a short way to recover and save life to those who are in conflict.

- Emergency enumerators and data, NFIs/shelter distribution collection: 6 personnel and 40 volunteers
- FSL staffs 2 engineers, 7 technicians and 15 volunteers
- Education and Protection staffs: 6 social workers and 15 volunteers
- Peace building officers: 3 staffs and many committees all over the areas of intervention.

- Admin officers and staffs in all offices and sub-offices 26 personnel.
- Good performance of capacity to mobilize the communities and leaders to implement projects and monitor the activities/outputs.

Funding:

GFO funding is based on projects and partnership with INGOs and sometime gifts and cooperation with private institution.

Since 2007, GFO had good partnership with International communities including UN Agencies, IOM, ICRC and INGOS.

- Strategic partnership was signed with WVI, CIS, Alight to implement common projects in the geographical areas of our common intervention.
- United State Institute of Peace (USIP)/GFO signed a contract of training Darfur leaders on Customary Law (all over Darfur) – 300 leaders of different levels of different ethnic groups in the 5 States of Darfurs. (16 workshops conducted). 2006
- GFO/IRC signed TOR for training IDPs leaders in Leadership and camp Management in South Darfur and Central Darfur 2008/2009
- CHF/SHF. GFO is eligible for CHF/SHF funding since 2011 up to date. Last project was in February – to October 2025 Es/NFI distribution.

Number of people Served:

People who received services from GFO:

- 1- Internally Displaced Person (IDPS) # 1,020,900 individuals received humanitarian services (Food, Non-food and shelters, Health, Water and Sanitation, education and protection since 2006
- 2- Host rural communities who hosted IDPs. # 157,000 households received FSL, training on IGAs, GBV and women empowerment.

3- Refugees: 26,000 individuals who received emergency services including reception kits.
